- Identifying information, such as a driver's license.

The information we collect is used for the following purposes:

- To provide you with continuous service and to credit and/or bill you for that service;
- To assist us in the collection of accounts;
- To respond to your inquiries about service use and billing;
- To prevent fraud with respect to both you and our companies;
- To meet legal and regulatory requirements.

It may be necessary to share your billing and consumption information with third party agencies. For example, your billing and consumption information may be provided to the IESO with whom you have chosen to enter into a separate contract.
